

## IMPORTANT INFORMATION FOR ENTRANTS TO THE ECCO CAR PARK RANDOM MONTHLY DRAW

**Details of Participation:** Information on how to enter the ECCO Car Park Monthly Random Draw (Random Draw) forms part of these Details of Participation and entry is deemed as acceptance of them.

The purchase of an ECCO Ltd car park ticket and the completion of your personal details on the back of the ticket are necessary to enter the Random Draw and redeem a Prize.

The Random Monthly commences 4/1/2012 at 6:00am AEST and closes 31/12/2012 at 5.00pm AEST and will run monthly from January to December 2012 with 12 prizes drawn during that time.

Eligible entries not received by the entry time and date at the end of each month will be entered into the next month's draw and will be ineligible to win in the month the car park ticket was purchased.

Entries not completed in accordance with these Details of Participation will not be eligible to win a Prize.

**Who Can Enter:** The Eumundi Car Park Lucky Draw Prize is open to Australian residents and visitors only aged 18 years & over who submit an eligible entry via the entry boxes placed at one of three car park gates or by posting to PO Box 482, Eumundi Q 4562.

Prize winners must be capable of shopping at Original Eumundi Markets or with Original Eumundi Market traders online or by other means to redeem their prize. The total prize does not include postage or transport of any items, which must be borne by the winner.

Multiple entries are permitted per person depending on how many times you park at the ECCO Car Park. Employees &/or associates of ECCO Ltd are not eligible to enter the Random Draw or win a Prize.
